

Privacy Policy

Fleet Sync is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Fleet Sync website and governs data collection and usage. By using the Fleet Sync website, you consent to the data practices described in this statement.

Collection of your Personal Information

Fleet Sync collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Fleet Sync also collects anonymous demographic information, which is not unique to you, such as your area code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Fleet Sync. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by Fleet Sync for the operation of our service, to maintain quality of our service, and to provide general statistics regarding use of the Fleet Sync website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Fleet Sync public message boards, this information may be collected and used by others. Note: Fleet Sync does not read any of your private online communications.

Fleet Sync encourages you to review the privacy statements of websites you choose to link to from Fleet Sync so that you can understand how those websites collect, use and share your information. Fleet Sync is not responsible for the privacy statements or other content on websites outside of the Fleet Sync and Fleet Sync family of websites.

Use of your Personal Information

Fleet Sync collects and uses your personal information to operate the Fleet Sync website and deliver the services you have requested. Fleet Sync also uses your personally identifiable information to inform you of other products or services available from Fleet Sync and its affiliates. Fleet Sync may also contact you via surveys to conduct research about your opinion of current services or of potential new services

that may be offered.

Fleet Sync does not sell, rent or lease its customer lists to third parties. Fleet Sync may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Fleet Sync may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Fleet Sync, and they are required to maintain the confidentiality of your information.

Fleet Sync does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Fleet Sync keeps track of the websites and pages our customers visit within Fleet Sync, in order to determine what Fleet Sync services are the most popular. This data is used to deliver customized content and advertising within Fleet Sync to customers whose behavior indicates that they are interested in a particular subject area.

Fleet Sync websites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Fleet Sync or the site; (b) protect and defend the rights or property of Fleet Sync; and, (c) act under exigent circumstances to protect the personal safety of users of Fleet Sync, or the public.

Use of Cookies

Fleet Sync websites may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the web server that you have returned to a specific page. For example, if you personalize Fleet Sync pages, or register with Fleet Sync sites or services, a cookie helps Fleet Sync to recall your specific information on

subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Fleet Sync website, the information you previously provided can be retrieved, so you can easily use the Fleet Sync features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Fleet Sync services or websites you visit.

Security of your Personal Information

Fleet Sync secures your personal information from unauthorized access, use or disclosure. Fleet Sync secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.

Fleet Sync will occasionally update this Statement of Privacy to reflect company and customer feedback. Fleet Sync encourages you to periodically review this Statement to be informed of how Fleet Sync is protecting your information.
